

# **Funding Continuous Improvement**

On May 15th, 2018 Catskill Central School District voters will head to the polls to decide on a \$41,793,028 budget for the 2018-2019 school year. The budget carries a projected tax levy increase of 3.03 percent, which is within the limit set by the NYS property tax cap. Because Catskill's budget stays within the cap, most District homeowners will be eligible to receive the NYS STAR Property Tax Rebate this fall.





largely to inflation, rising health insurance premiums, contractual obligations, increases in BOCES services costs, and program initiatives.

Program initiatives include adding four part-time (.5) armed security guards (positions will be staffed by fully vetted, retired law enforcement officers) with two assigned to the Middle/High School and two at the Elementary School; and increasing a part time (.4) speech position to full time to meet student need at the Middle/High School. The budget also expands electives at the High School with the addition of Journalism, Mythology & Literature, and Creative Writing courses, as well as new distance learning offerings in Meteorology, Veterinary Science, Skills for Employment, and Italian.


"Our goals in developing this budget were to strengthen our academic program, maintain our current student to teacher ratio, and continue to meet the individual needs of our students," explained Superintendent of Schools, Dr. Ronel Cook. "By using conservative fiscal practices, this budget also provides for the financial stability of our District and keeps the tax increase within the NYS tax levy limit."

Staffing levels were adjusted to match program needs and student enrollment; following retirements this year, the District will not fill two special education teaching positions at the Middle/High school. These reductions, done without layoffs, were based on less need in that area and therefore will not impact what students are offered. The District also applied \$948,280 in fund balance to the budget to reduce the impact of cost increases on the tax levy.

Voters will also be asked to elect three candidates to the Board of Education and decide on an appropriation for the support of the Catskill Public Library.



### What happens if the budget is defeated?

If voters do not approve the proposed budget on May 15 the Board of Education can put the same budget, or a revised budget, up for vote on June 19, or adopt a contingent budget. If the budget is defeated on June 19, the Board must adopt a contingency budget.

A contingency budget holds the tax levy increase at 0%, regardless of inflation, contractual obligations, and other cost increases incurred by the District. A contingency budget also prevents spending on new

equipment, except when concerning safety, and limits public use of District facilities. However, all state mandated programs, including those not funded by state aid, would need to be retained. These regulations mean that in a contingent budget, the Board would need to cut \$540,646 from the current budget proposal. This would require the District to consider program reductions, including staff layoffs in instructional and non-instructional areas.

# A few of the great things happening at Catskill CSD this year:

- Catskill's Graduation Rate rose to 90% in 2017, and our goal is 92% for 2018
- Two teams from CMS and one from CES advanced to the Odyssey of the Mind NYS Tournament, and a team from CMS is now headed to the 2018 World Finals
- CHS music students were selected to perform at some of the highest levels, including one with the All-State Choir and two with the Honors Choir at Carnegie Hall
- The Cats have claimed six conference titles this year so far; the CHS boys soccer, girls soccer, girls volleyball, boys basketball, bowling, and wrestling teams are all Patroon Conference champions

#### 2018 Board of Education Election

There are four candidates running for three open seats on the Board of Education. Elected candidates will serve three-year terms from July 1, 2018 to June 30, 2021. The highest vote getter, excluding any incumbent candidates whose current terms expire June 30, 2018, will also fill the remainder of an unexpired vacant seat for a term running May 16, 2018 through June 30, 2018.

The candidates will appear on the ballot in the following order:

- Jeremy Engelin
- Ryan Osswald

### **Voter Qualifications**

To be eligible to vote on May 15, you must be:

- A citizen of the United States 18 years of age or older.
- A resident of the Catskill Central School District for a period of 30 days or more directly preceding the date of the vote
- Registered to vote with either the School District or the Greene County Board of Elections

### **Absentee Ballots**

Qualified voters who are unable to appear during the voting hours of 1:00 p.m. to 9:00 p.m. on Tuesday, May 15, 2018 may vote by absentee ballot. To obtain an absentee ballot you must first complete an application explaining why you are unable to appear to vote for one of several reasons:

- You are a patient in a hospital, or unable to appear personally because of physical disability
- Your duties, occupation, business or studies require such absence
- You will be on vacation elsewhere on voting day

An application can be obtained by contacting the Board Clerk at the Superintendent's Office, 518-943-4696. Completed applications must be received by the Board Clerk no later than the day before the election if the ballot is to be issued to the voter in person, or at least seven days before the election if the ballot is to be mailed to the voter.

Absentee ballots must be received by the Board Clerk, not later than 5:00 p.m. on Tuesday, May 15, 2018.
