Schedules the use of and prepares the Fitness Center for student use;

Participates in scheduling of Fitness Center related activities;

Participates in the budget process for equipment, programs and improvement of facilities and equipment;

Responsible for conducting periodic inspections of equipment to insure that it is safe for use.
