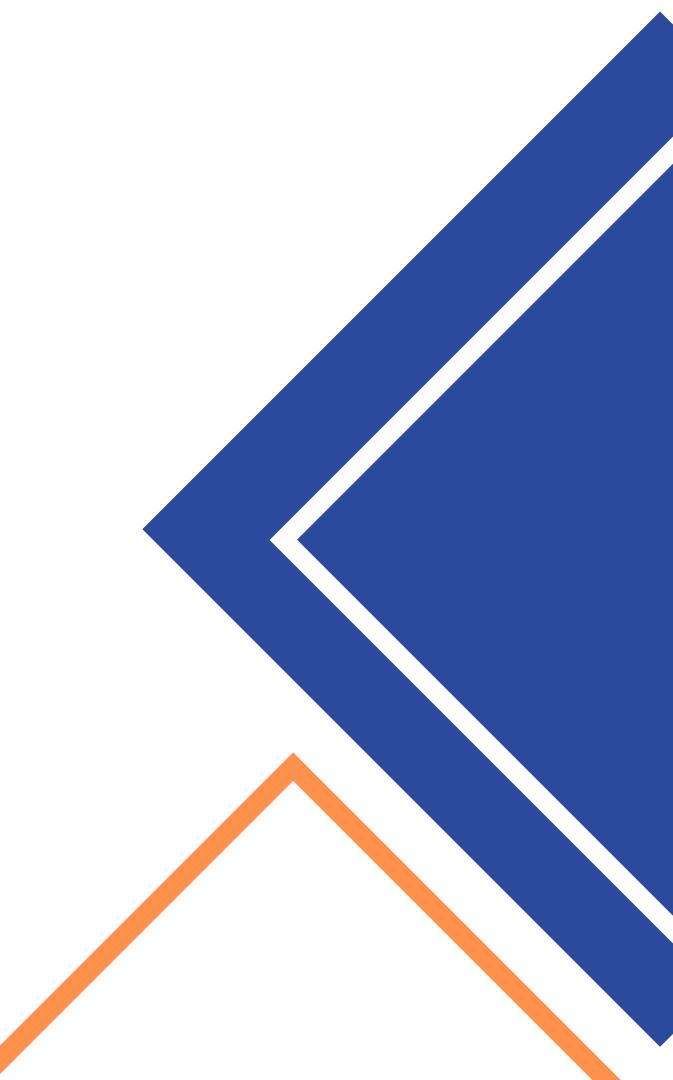

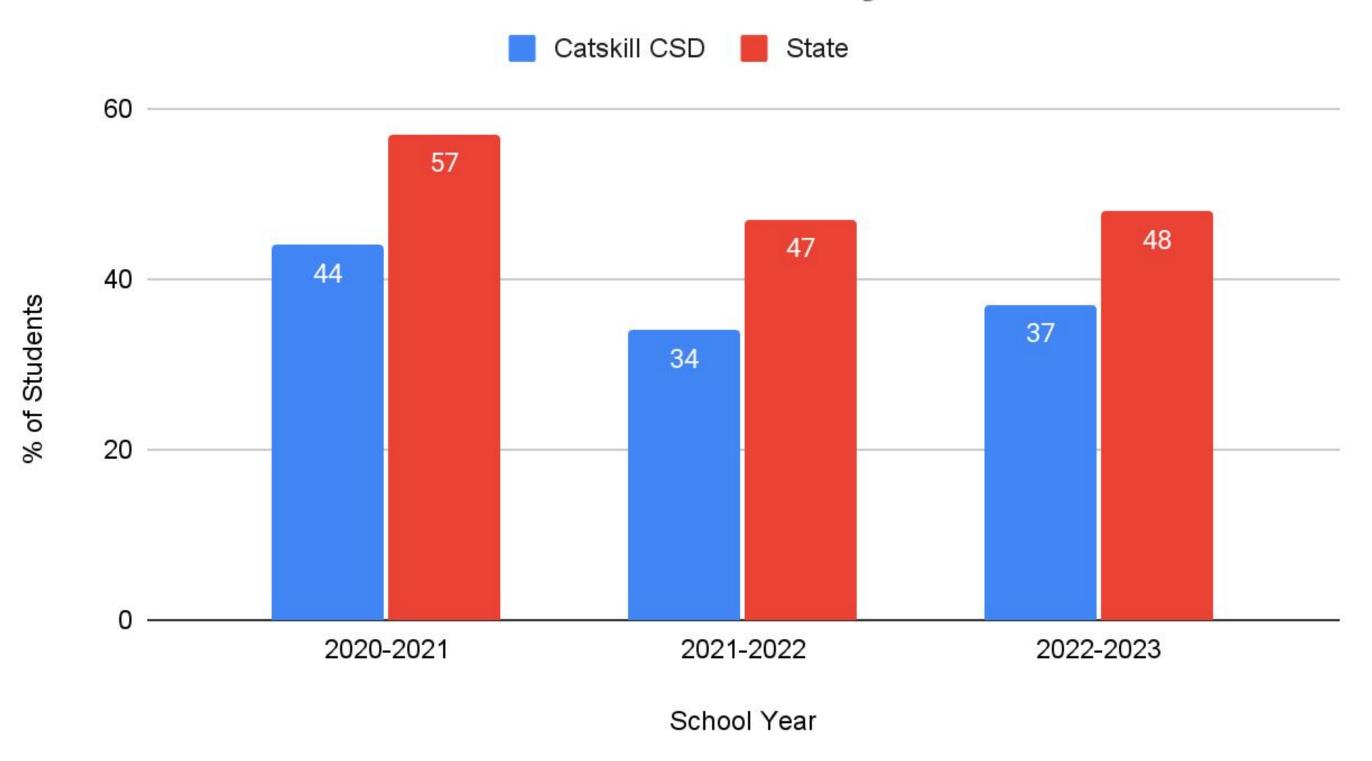

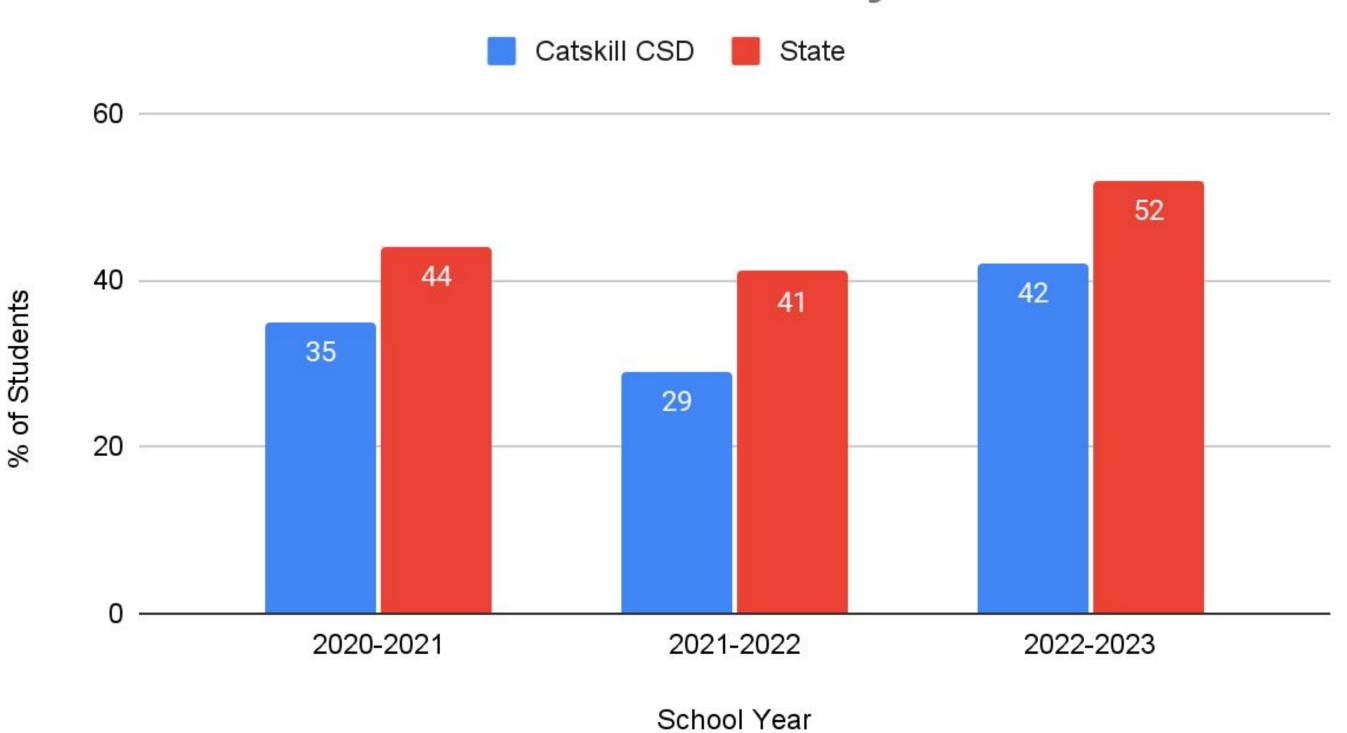
3-8 ELA Proficiency







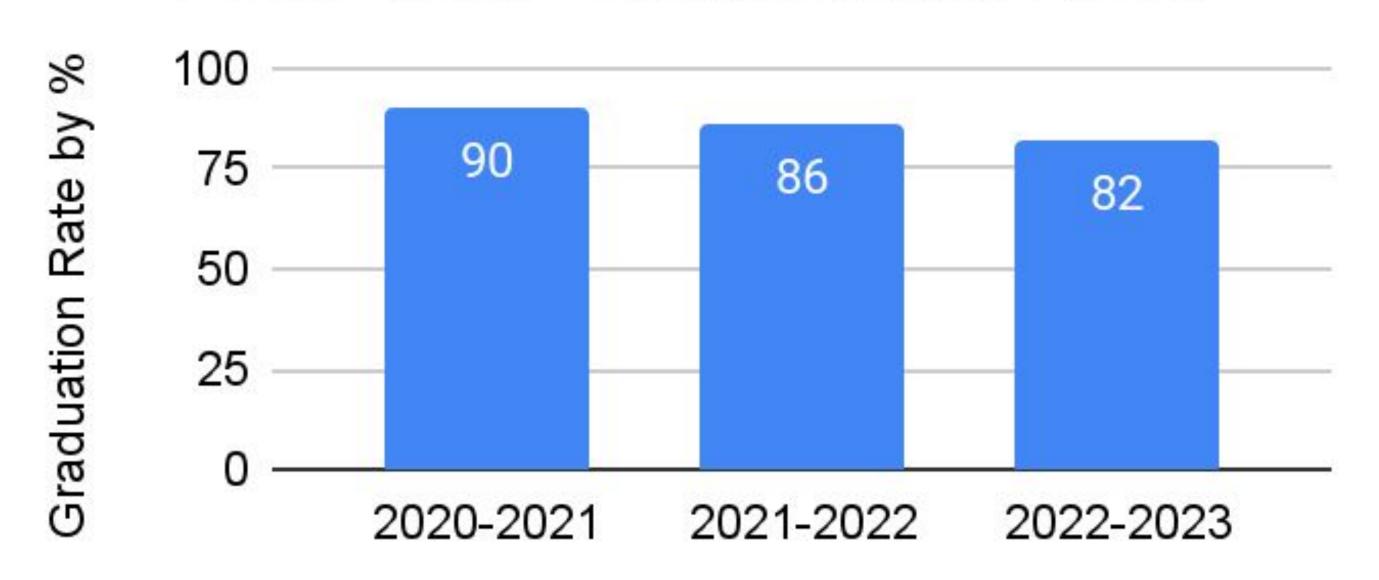
3-8 Math Proficiency







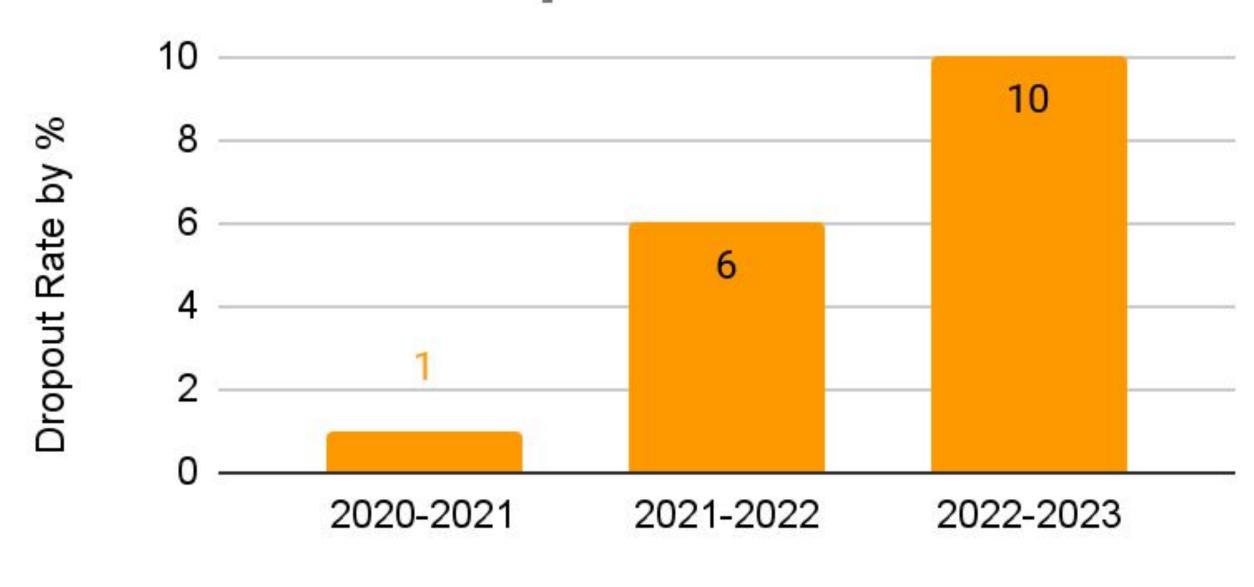
Four Year Graduation Rate

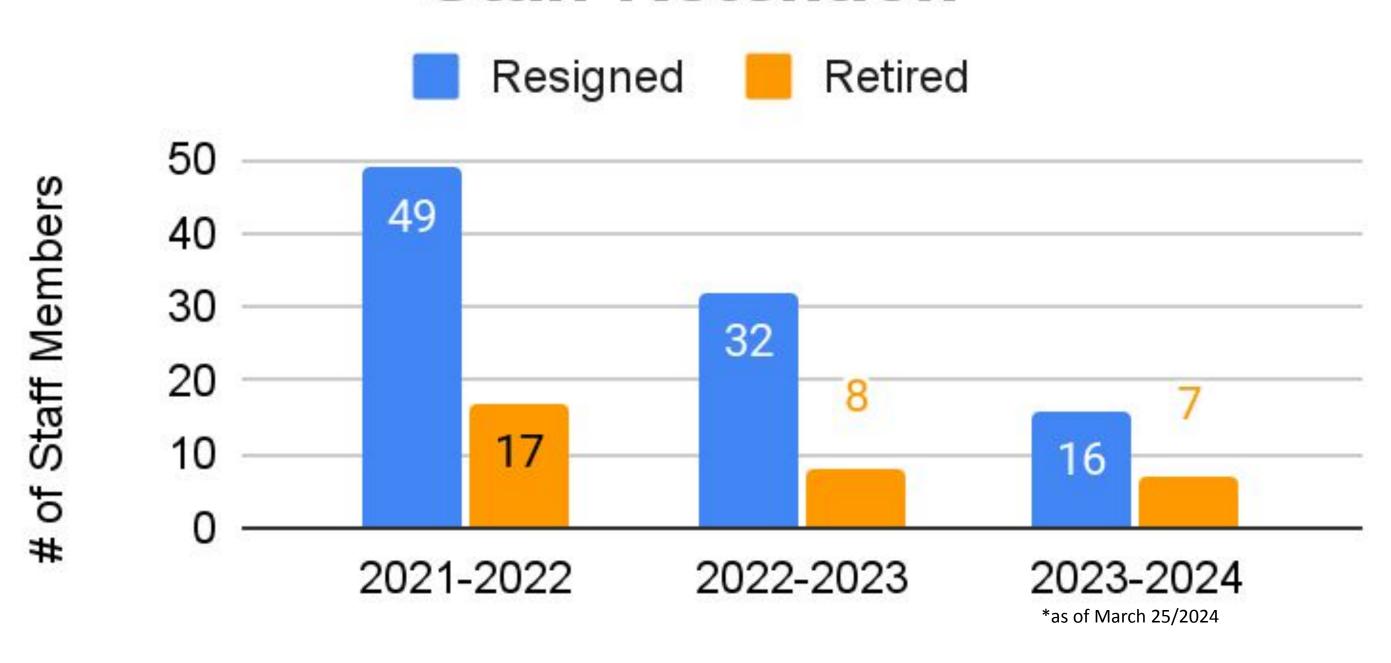
