<p>* Should the proposed budget be defeated pursuant to Section 2023 of the Education Law, a contingency budget for 2024 – 2025 requires that the tax levy increase by 0.00% and caps spending in certain areas. Therefore, a budget gap of \$692,445 would need to be addressed to reach the contingency level. The anticipated changes in order to meet the contingency level would possibly include the following: potential program reductions in instructional and non-instructional positions; potential program reductions in interscholastic sports programs; eliminating equipment spending unrelated to safety and security, and potential reductions in BOCES services.</p>
